WHO WE ARE:

WHAT YOU WILL BE DOING (DESCRIPTION):

The Town of Apex is looking for an enthusiastic and multi-talented Masters of Landscape Architecture (MLA) or Master of City and Regional Planning (MCRP) students to help us continue making our community "the peak of good living." The interns' daily responsibilities will be to assist the Parks Planning Project Manager with various tasks and projects. The intern will play an important role in our continued efforts to evaluate, review, and plan the town's parks and greenways. Specifically, the internship will include working with Parks Staff along with various departments as a part of the Technical Review Committee as well as assisting PRCR staff members in updating and maintaining inventories of park facilities and greenway trail and amenities. The Parks Department is wrapping up an update to the Parks, Recreation, Greenways and Open Space Master Plan and the intern will be working with staff to update maps and begin implementation of the plan. The Parks and Greenways Planning staff will also be actively involved in the oversight of construction of several major greenway corridors in town and the intern may be asked to complete site visits, document project status through photos, updates to social media, and provide materials to assist contractors and staff. Two exciting projects will begin public engagement to develop site plans including a renovation of West Street Park at the edge of the extending downtown activity area and a Hunter Street Park Bike Track.

Additionally, the intern may be asked to assist with general office work, interact with various boards and committees, attend public meetings, handle research inquiries, and perform other duties as assigned to gain valuable professional experience.

A successful applicant will possess excellent design, communication, data collection, time management skills, the ability to perform and interact in a team environment, and a desire to learn. Proficiency in ArcMap/ ArcGIS Pro, AutoCad, Adobe Creative suite a plus.

The Town anticipates hiring an MLA/ MCRP candidate for a minimum 32-hour per week summer internship (June – August) that will transition into a part-time internship (10-hrs per week) when the academic year resumes.

A SAMPLE OF THE ESSENTIALS (DUTIES & TASKS):

- Assist in the implementation of the PRCR Parks, Greenways, and Open Space Master Plan
- Assist in the evaluation and review of development projects (Technical Review Committee)
- Review greenway trail plans and profiles

- Compile and review GIS data for park facilities, greenway trails and site amenities
- Use IDT and Bluebeam software to review and comment on developer plans and plats
- Perform field evaluations of greenway construction in conjunction with Infrastructure Inspection staff
- Participate in project meetings and provide support for Bond Projects – including Middle Creek Greenway, Beaver Creek Greenway, Apex West Greenway (ATT Connection) and Pleasant Park
- Assist department in achieving goals and objectives by providing creative support such as graphic materials, landscape plans, sketch plans, and more
- Work with PRCR staff to draft outreach and public messages, publications, and other strategic communications
- Other special projects as assigned

WHAT YOU'LL NEED (MINIMUM MUST-HAVES):

The successful applicant will possess excellent design, communication, data collection, time management skills, the ability to perform and interact in a team environment, and a desire to learn. Proficiency in ArcMap/ ArcGIS Pro, AutoCad, Adobe Creative suite a plus.

WHAT WOULD SET YOU APART (PREFERRED QUALIFICATIONS):

The preferred applicant will be an MLA/ MCRP candidate and can provide a portfolio of course work or professional projects that illustrates spatial awareness and understanding of the built environment. Demonstrates an understanding and experience in public engagement efforts as a part of the public planning process.

PHYSICAL REQUIREMENTS:

- Must be able to physically perform the basic life operational functions of climbing, balancing, kneeling, reaching, standing, walking, lifting, fingering, grasping, talking, and hearing.
- Must be able to perform light work exerting up to 20 pounds of force occasionally, and/or up to 10 pounds frequently, and/or a negligible amount of force constantly to move objects.
- Must possess the visual acuity to read, to prepare and analyze blueprints, maps, data and figures, perform visual inspections, and operate a computer.
